ORDINANCE NO. 203

AN ORDINANCE TO ANNEX PROPERTY TO THE CITY OF 91 JUN 13 P2:50 BARLING, ARKANSAS LYING IN A GENERAL SOUTHEASTERLY DIRECTION OF BARLING, ARKANSAS, FOR A SPECIAL ELECTION THEREFORE, AND FOR OTHER PURPOSES.

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE CITY OF BARLING, ARKANSAS, THAT:

SECTION 1: That pursuant to Arkansas Code Annotated 14-40-302 et seq, it is hereby proposed that a special election be held to annex contiguous lands to the City of Barling, Arkansas more specifically as follows:

All of Sections 8, 9, 10, 11, 14, 15, 16, and 17 and part of Sections 1, 2, 3, 4, 5, 6, 7, 12, 13, and 18, all in Township 7 North, Range 31 West in Sebastian County, Arkansas more particularly described as follows:

BEGINNING at a point on the Northerly right-of-way line of Arkansas State Highway 255, said point being 500.0 feet Easterly of the West line of the Northeast Quarter of said Section 5; thence South 300.0 feet; thence West 500.0 feet to said West line of the Northeast Quarter; thence South along said West line of the Northeast Quarter to the Northeast corner of the South Half (Government Lot No. 1) of the Northwest Quarter of said Section 5; thence West along the North line of said South Half of the Northwest Quarter and along the North line of the South Half (Government Lot No. 1) of the Northeast Quarter of said Section 6 to the Northwest corner of the East Half of said South Half the Northeast Quarter; thence South along the West line of said East Half of the South Half of the Northeast Quarter and along the West line of the East Half of the Southeast Quarter of said Section 6 to the Southwest corner of said East Half of the Southeast Quarter; thence West along the South line of said Section 6 to the South Quarter corner of said Section 6; thence South along the West line of the East Half of said Section 7 and along the West line of the East Half of said Section 18 to the South Quarter corner of said Section 18; thence East along the South line of said Section 18, the South line of said Section 17, the South line of said Section 16, the South line of said Section 15, the South line of said Section 14, and the South line of said Section 13 to the South Quarter corner of said Section 13; thence North along the East line of the West Half of said Section 13, the East line of the West Half of said Section 12, and the East line of the West Half of said Section 1 to the Northeast corner of the Southwest Quarter of said Section 1; thence West along the North line of said Southwest Quarter to the Southeast corner of the West Half of the South Half (Government Lot No. 1) of the Northwest Quarter of said Section 1; thence North along the East line of said West Half of the South Half of the Northwest Quarter to the centerline of Arkansas State Highway 22; thence Westerly along said centerline to the East line of said Section 4; thence South along said East line to the Southerly right-of-way line of the Missouri Pacific Railroad; thence Westerly along said Southerly right-of-way line to the East line of the Northwest Quarter of said Section 4; thence South along said East line of the Northwest Quarter to the Southeast corner of the North Half (Government Lot No. 2) of the Northwest Quarter of said Section 4; thence West along the South line of said North Half of the Northwest Quarter to the West line of said Section 4; thence North along said West line to the Northerly right-of-way line of said Arkansas State Highway 255; thence Westerly along said Northerly right-of-way line to the POINT OF BEGINNING.

SECTION 2: That the aforesaid property can benefit by such annexation in that police and fire services will be provided therefore and are valuable to the City of Barling by reason of their adaptability for prospective municipal uses in the future.

SECTION 3: The schedule of services to be included within three (3) years after the date such proposed annexation becomes final will be police and fire protection and may include water services, if necessary.

SECTION 4: This board hereby set for the City of Barling, Arkansas a special election to be held on the $\underline{11th}$ day of \underline{June} , $\underline{1991}$, for the prupose of approving or disapproving annexation of the aforedescribed property.

SECTION 5: This ordinance repeals Ordinance No. 202 in its entirety, in order to correct an error in property description.

SECTION 6: Passed this 10 day of May, 1991.
