#### ORDINANCE NO. 258

AN ORDINANCE FOR THE PURPOSE OF REQUIRING BUILDING PERMITS FOR IMPROVEMENTS, CONSTRUCTION AND RENOVATION OF REAL PROPERTY WITHIN THE CITY OF BARLING, ARKANSAS, FOR ESTABLISHING PENALTIES FOR NON-COMPLIANCE, THEREWITH AND FOR OTHER RELATED PURPOSES

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE CITY OF BARLING, ARKANSAS, THAT

SECTION 1: It shall be unlawful to construct, improve or renovate any real property within the City of Barling without first having obtained a building permit.

SECTION 2: The City Administrator shall appoint a building inspector who shall be subject to removal for any reason. The building inspector may be employed in any other additional capacity in recognition of the fact that building inspector is not a full-time position. At such time as a building permit application has been filed together with a statement of the estimated costs, the applicant shall provide the following:

SECTION 4: The "estimated cost" as used herein refers to the reasonable value of all services, labor and material necessary for the initiation and completion of the construction, improvement or renovation.

SECTION 5: The building permit issued by the City shall be displayed in a prominent place on the job site wherein the construction, improvement or renovation is taking place.

SECTION 6: Any person, firm or company found to have violated this Ordinance shall be fined in an amount not to exceed the sum of \$1,000.00 Each day in which construction, improvement or renovation is conducted without compliance with this Ordinance shall constitute

a separate violation.

SECTION 7: The building inspector and persons working with the building inspector shall have the right at reasonable times to make periodic inspections of any premises upon which there is any construction, improvement or renovation whether a building permit has been issued or not to determine whether the same is being performed pursuant to applicable law.

SECTION 8: The provisions of this Ordinance are hereby declared to be severable and a decision by any court of competent jurisdiction that a provision of this Ordinance or any application thereof is illegal, invalid or unconstitutional, shall not effect the legality, validity or constitutionality of the remaining provisions or applications of this ordinance.

SECTION 9: All construction, improvement or renovation that results in or is intended to result in modification for cosmetic or maintenance purposes only, including but not limited to painting, roofing, and the addition of siding, is excluded from the requirements of this Ordinance.

SECTION 10: All ordinances in conflict with this Ordinance are repealed and Ordinance No. 173 is specifically repealed.
